Winter Tax 2011

Beginning December 1, 2011 winter taxes are due & payable to Green Charter Township Treasurer. Payments may be made at the township hall during treasurer's hours, dropped in the after-hours drop box located in front of the township hall, or mailed to: **PO Box 23 Paris, MI 49338**. If you require a receipt, please enclose a self-addressed stamped envelope.

Escrow Accounts: Upon the request of a mortgage company, a copy of the tax bill is forwarded. The original tax notice is sent to the property owner.

To avoid incurring a 3% penalty, taxes need to be paid by Tuesday, February 14, 2012. The last day the Township Treasurer may accept payment of 2011 taxes is Wednesday, February 29, 2012. March 1, 2012 all delinquent taxes will be turned over to the Mecosta County Treasurer's Office.

A tax collection calendar is on the reverse side of this letter. It was created several weeks ahead of the tax notices and is subject to change.

Board of Review

December Board of Review will be held at 8:00 a.m. on Tuesday, December 13 at the Township Hall. This is to rectify principal residence exemptions, mutual mistakes, or clerical errors. The trail would cross Northland Drive from Mill Street to the Township Hall then continue down to the Stone Fish Hatchery Park.

Dog Licenses

You may purchase dog licenses at the Township's Treasurer's office during the months of December, January & February. Proof of rabies vaccine is required. You will be able to purchase a 1 year or 3 year license. The license expires the same day as the rabies. License fees are as follows:

1 year license:	\$8.00 male/female
	\$4.00 spayed/neutered
3 year license	\$20.00 male/female
	\$10 spayed/neutered
