The televising of the sewer system is nearly 95% complete.

Cost will come considerably lower than estimated.

Reported the lines are in incredibly good shape with few roots.

They will foam treat where needed for roots.

In one location ground water is leaking in. They will seal it up.

There was infiltration around one manhole, that will be cleaned and sealed.

Two manhole covers will need to be raised to bring up to ground level risers.

LESSONS FROM THE STORM & EMERGENCY FACILITY

Parkhill Cemetery had considerable damage:

- 10 trees damaged and required removal
- 2 headstones moved and needed resetting
- 1 flower urn broken

West Cemetery limb damage.

The supervisor reported the new bids for tree removal/trimming has been sent out for

1 tree in West Cemetery and 5 tree trimming,

1 tree to be removed in Charlie Brown Park.

The Boy Scouts will be volunteering to remove the veteran flags which have been damaged in the cemeteries.

Currently there has not been any bills turned in for any damages from the storm. Much has been done by volunteers at the Stone Hatchery Park and township hall facilities.

Internet tower had no damage to tower. It did take 2 hours to get to the tower, because of fallen trees. The damage from the storm has been reported to the township insurance company and the adjuster must review the damages. It is looking like there will be coverage.
