OLD BUSINESS

STONE HATCHERY PARK RENTAL RATES

It was brought to the attention of the board, because of the increased cost of portable restrooms at the Stone Hatchery Park, rental rates need to be increased. There was a discussion.

SANITARY SEWER FEASIBILITY STUDY

The sanitary sewer feasibility study prepared by Fleis & Vandenbrink was presented to the board by the supervisor for the board to review. In the study there were three options submitted.

- 1. 220th Avenue route
- 2. Northland Drive route
- 3. 205th Avenue route

F&V recommendation was option #3 the 205th Avenue route. This option is most cost effective when comparing full project costs estimates. The additional flow would not change the plans for the new lift station.

There was a lengthy discussion. No action taken.

NEW BUSINESS

AMERICAN RESCUE PLAN SUBSIDY FUNDS 1St REVIEW

The Green Charter Township application for the American Rescue Plan Funds has been submitted and approved. The estimated Federal funds to be received is \$348,651, based upon population.

There was a lengthy discussion.

- Restriction for usages water, sewer, broadband
- Anticipated first payment of the money (50%) will be available in two weeks
- The other 50% later in the summer of 2022.
- Recommend using in multi areas in the township.
- Sewer lift station replacement
- Towers to provide high speed internet in areas of the township where not currently accessible.

- Projects must be completed by December 31, 2026.
- Recommended the board review the information and schedule a special meeting to decide on projects.
- Suggest waiting on projects until the first payment has been received.
- No action taken.

SEWER RATES

There was a discussion regarding an increase in the Sew Rates.

Bendzinski & Co. Finance Advisor recommends using some of the American Rescue Plan Funds, Sewer system replacement funds and the general fund low interest loan, it would save having to finance.

The consensus of the board was that an increase of the sewer customer quarterly charge should be increased. The last increase was in 2007, suggesting a cost-of-living increase be added each year.

MOTION was made by J. Peek and supported by G. Todd to send notice to the sewer customers explaining the increase of \$13.00 will be on the quarter billing of October, November, & December of 2021 (\$96.00), because of the needed replacement of the sewer lift station.
