The treasurer reported the State Shared Revenue has been received for the period of January & February 2020, which is included in 2019-2020 budget numbers.

She also explained that because of the stay at home orders, the State Shared Revenue could possibly decrease 50 percent. (\$50,000.-\$60,000. best estimate)

The supervisor recommended the following non-essential capital improvement projects for this current budget year be delayed:

West Cemetery drive, 190th drive improvements, Stone Hatchery entrance opening, computer network, hall window replacement, phone system, stone wall repair, Stone Hatchery Park security light, estimate of \$40,700.00.

There was a lengthy discussion regarding funding and cost cutting possibilities.

ELECTRONIC MONIES COLLECTION

First Data will add a percentage to cover the processing fee, or what the township would charge.

First Data will evaluate the percentage fee monthly, making sure it is enough to cover the amount of processing fee. 3% was recommended to start
