PUBLIC COMMENTS

<u>AMERICAN RED CROSS – DICK DUNNILL DISASTER PROGRAM</u> <u>SPECIALIST (WEST MICHAGAN CHAPTER)</u>

Mr. Dunnill was present and addressed the board and expressed the interest the Red Cross has to use the Green Charter Township hall for a storage site facility for emergency supplies and a shelter site. There was a discussion:

- There would be a signed agreement with Green Charter Township and The Red Cross.
- Township hall would be used for a shelter opened by the Red Cross.
- Cleanup of facility would be done by the Red Cross.
- Standby generator and kitchen facility are at the township hall.
- Mecosta County does have other facilities available for use in a disaster.
- 24-7 access would be needed.
- No compensation from the Red Cross.
- Red Cross would bring supplies.
- Red Cross has shelter trailers and emergency response vehicles.
- One concern would be if the township is already rented for an event.
- The discussion was that if there was a disaster, the event would likely be canceled.
- It was suggested to put in the hall rental contract to hold harmless the township if in an emergency the rental would be canceled.
- Red Cross insurance would cover any damages by them or residents using the facility.
