**Review Youngs Consulting invoice** 

The County chose to split off the construction phase from the design phase.

A modified permit approved by DEQ and the Road Commission was received permitting the project to move forward.

The design phase was completed by Youngs Consulting Company listed below:

- MDEQ permit application modification –new drawings for MDEQ
- 2 soil borings
- Hydraulic analysis for scour, engineering for GRS design vs deck plans
- Bridge plans with arch span structure for county to rebid for construction.

The bid request for construction has been sent out.

Mr. Youngs was present to explain and answer questions.

Originally several different bids and contracts that had been received by the road commission was discussed by the board.

The Road Commission decided to split the design from the construction bid because the bridge design had changed to a culvert.

All the work listed on Youngs Consulting Company invoice has been completed.
