The supervisor presented copies of the correspondence from Tim Nestle, Superintendent Manager of the Mecosta County Road Commission from email dated Friday June 7, 2019 about work on 220th Ave. north from 22 Mile to Meceola Rd. which included the following:

That \$70k –\$75k was to fix just the worst spots. To overlay the entire two miles would cost around \$172,000. For the county to turn it back to gravel would cost around \$10,000.
