GREEN TOWNSHIP'S INSURANCE LIABILITY COVERAGE OPTION

Correspondence has been received from the township's insurance carrier, Berends/Henddricks/ Stuit, suggesting the township consider increasing the township's liability insurance from 1 million to 2 million. There was a discussion.

MOTION was made by N. Stephan and supported by J. Peek to increase the township's liability insurance to 2 million.

INTERNET TOWER INSPECTION

The tower inspection report was presented to the board and will be placed on file.

Representatives of ISI, Rick Dean and Larry Cox were present. The cost of the inspection is paid by ISI and the weed and brush clearing is done in the spring and fall.

Correspondence has been received from ISI informing the board that they were forced to terminate the lease relationship with Skyweb.

- 1. Skyweb was not in compliance with the requirements of the lease, listing eight issues.
- 2. They were also delinquent in the rental lease fees.

This caused interference with renting to other companies.

There was a discussion concerning service to the customers on the tower after termination of Skyweb. ISI representative reported they will connect service on the tower for township residents requesting service. If residents call the township, they are given the names of the servers in this area, Casair, HughesNet and ISI.

PUBLIC COMMENTS

INTERSECTION OF 23 MILE AND 180TH

- It was brought it to the attention of the board the need for an all way stop (3 way) at 23 Mile (dead end) and 180th Avenue.
- A need for guardrails to be installed at this intersection.
- Request the Road Commission install reflective lines on all stop signs, noting they do make the stop signs more visible.
