TO THE QUALIFIED ELECTORS OF: BIG RAPIDS PUBLIC SCHOOLS

PLEASE TAKE NOTICE that any qualified elector within Big Rapids Public Schools who is not already registered, may register to vote at the office of the City/Township Clerk; the office of the County Clerk; a Secretary of State branch office, or other designated state agency. The last day to register in any manner other than in-person with the local clerk is Monday, April 22, 2024.
