PLEDGE OF ALLEGIANCE

CALL TO ORDER: 6:00pm ROLL CALL Cushway, MacFarlane, Riebow, Thorne, Walsh, Kruse, present. Meads absent.

PUBLIC COMMENT- None

ADDITIONS TO AGENDA:

1. Cushway had questions about ISI judgement. The board was awarded sanctions from ISI and wonders how we satisfy that judgement. Kruse stated that the board would have to go back to court.
2. BOR Training is available on two separate dates if any board members would like to attend to learn more about the Board of Review process.
3. Parks and Recs Chair, Cindi Postema. Wants to discuss grants for parks and recs. Stated someone needs to register as an authorized official (Supervisor, Clerk or Treasurer). Jilliane-Treasurer volunteered to register as the authorized official. There was discussion about the parks survey (it is still available at www.greentownship.org). Supervisor explained that this is a contributing grant and not a matching funds grant. Supervisor has spoken to the DNR and they stated this type of grant is a great first step.
Cindi stated we can file for up to 3 grants in one year but each grant needs to be for one individual park per permit.
4. Supervisor gave an update that the last check for the MET funds has been released and the reimbursement check will be available from the county tomorrow. Working with the county has been seamless and we have been grateful to work with them.
5. The 6th Circuit Court sent a letter to both parties concerning the appeal for the temporary injunction with Gotion. They are requesting both parties to address whether the injunction is a moot point in light of the state's notice of default or what will the lawsuit look like if not moot. May need a special meeting to approve a letter from our council.
