PUBLIC COMMENT: Jessica Sharp, wants to speak for the other communities going through the same thing. Has anyone heard about Marshall, Mundy, Eagle etc? I have been to other communities and watched their meetings and feel there is a connection to them. There are 2 communities fighting Gotion and we have been called extremists. Concerned about government overreach and has a lot of questions about how Gotion is run.

ADDITIONS TO AGENDA:

- A lighting proposal was given by Cushway from Consumers Energy. Consumers gave a quote of \$4396 to replace all lighting with LED lights. Their incentives will cover \$2486 leaving us with a cost of \$1910 to switch all lighting to LED.
