**ADDITIONS TO AGENDA:**

1. A motion was made by Walsh to approve the amended agenda. Supported by Cushway. Motion was passed unanimously on a roll call vote.
2. Closed Session- A motion was made by Cushway to enter into closed session pursuant to MCL 15.168(e) and (h) to discuss a written legal opinion from the Township Attorney regarding litigation pending in the Mecosta County Circuit Court, captioned ISI v Green Charter Township, Case No 25-27734-CZ. Supported by MacFarlane. Motion was passed unanimously on a roll call vote. Closed session began at 6:08PM.
