# 220<sup>TH</sup> AVENUE FROM 22 MILE TO MECEOLA ROAD FINANCING DISCUSSION

- Is the Township able to pay for the wedging on 220<sup>th</sup> Avenue?

- Suggested township wait until the Mecosta County Road Commission in conjunction with the Mecosta County Commission decides if they will ask for county wide road millage.

The clerk suggested the board review the budget and consider amending the budget and use the amount that was budgeted in the Park and Recreation line item (large fixed asset), along with the allocated road budget, in this instance for this needed road project, which would nearly cover the estimated cost of wedging after Mecosta County Road Commission contributes the \$10,200.00 they indicated earlier they would pay this would leave an estimated cost of \$87,287.00.
