- 4. In narrowing down the search, monitors may be re-located.
- 5. Fleis & Vandenbrink has done a considerable amount of work for the City of Big Rapids.
- 6. Bid must be taken for projects over \$20,000.
- 7. This project needs an expert to monitor the bids.
- 8. Use of a professional to help review bids.
